MEMORANDUM

RE: Immigration Resolution Discussion

Action Requested: That the City Commission discuss the proposed Immigration Resolution presented by Commissioners Groff-Blaszak and Hunter.

Background: At the February 2nd City Commission meeting, Commissioners Groff-Blaszak and Hunter shared with the Commission and Staff the attached resolution on Public Safety's interactions with ICE and requested that the Commission add it to that meeting's agenda. After a brief discussion, the Commission agreed to add the proposal to a future agenda so that Staff and Commissioners would have time to review, research, and consider the proposal.

The proposed resolution states, in part:

1. The documented and enforced policies and procedures of the Department of Public Safety shall specifically

- a. Include "immigration status" as a named protected class in its Fair and Impartial Policing Policy; and*
- b. Prohibit officers and representatives from contributing resources or participating in federal immigration enforcement activities including, but not limited to:*
 - i. Riding along with federal immigration and customs enforcement officers;*
 - ii. Conducting joint investigations with federal immigration and customs enforcement officers; or*
 - iii. Sharing investigative information with federal immigration and customs enforcement officers.*

2. The City shall not use, nor provide for use, any public land, facilities or other resources for the establishment of a federal immigration and customs enforcement detention center.

3. The City shall not enter into any 287(g) agreement with federal immigration and customs enforcement agencies.

AND BE IT FURTHER RESOLVED THAT:

We call on the Kent County Sherrif to immediately cease compliance with any and all detainers issued by federal immigration and customs enforcement agencies and refrain from holding any person in detention at the request of federal immigration and customs enforcement agencies for

the purpose of investigating immigration status or securing their presence for immigration enforcement actions.

CURRENT POLICIES AND PRACTICES

Public Safety's current policies and practices relating to immigration issues are in the attached summary and FAQ. East Grand Rapids Public Safety does not and cannot enforce civil immigration matters. Our Fair & Impartial Policing policy prevents officers from asking about immigration status (attached).

Reviewing the draft resolution, the following observations are offered for Commission's consideration:

- With respect to 1.a., the Department's current Fair and Impartial Policing policy includes national origin as a protected class. Officers are already trained not to ask about national origin which includes immigration status.
- With respect to 1.b., the prohibition on contributing resources or participating in federal immigration enforcement already exists, as Michigan local enforcement officers cannot enforce civil immigration law. Officers are only authorized to enforce Michigan laws and local ordinances. However, if the City is presented with a valid Federal judicial warrant, then we must comply. The resolution, if adopted as written, has the potential to put the Department in an untenable position of having conflicting directives (i.e., a court order and a resolution at odds with each other).
- With respect to 2., the City has no publicly owned spaces that could be used for a detention center, and the City Commission would need to approve this action. Even if the resolution were approved, it is non-binding.
- With respect to 3., any 287(g) agreement is considered grant funding and requires City Commission approval under existing policy (attached). Even if the resolution were approved, it is non-binding.
- With respect to the final paragraph regarding the Kent County Sheriff, the Kent County Sheriff's Office has already publicly stated that the City of East Grand Rapids does not set policy for that department.

LEGAL ANALYSIS

The City Commission has been asked to consider resolutions on matters not within the City Commission's scope in the past and after consultation with staff has chosen not to adopt them. The decision not to pursue these resolutions is based on a 1982 legal analysis from City Attorney Robert W. Richardson. He noted that these types of resolutions are not appropriate for the City Commission. (attached)

The Cities of East Lansing and Ann Arbor have adopted immigration resolutions. Both have noted in their resolutions that they will not violate federal law.

SUMMARY

In many ways Michigan is further ahead on immigration issues as they relate to local law enforcement's interactions with the Federal government. By law, Michigan local law enforcement agencies cannot enforce federal civil immigration laws. They are only empowered to enforce Michigan laws and City ordinance violations. The only time our agency would have any interaction with immigration officials is if a valid judicial warrant was presented during a criminal investigation or other normal police encounter.

A discussion about the East Grand Rapids Public Safety Department's policies and procedures related to immigration is warranted to bring awareness to the community. Staff's review of the proposed resolution as compared to current Department policies and procedures show they are already being met or are outside the scope of the Commission's purview.

Staff is proud to note that these policies and procedures were in place before the recent change in Federal immigration enforcement tactics. This speaks highly to the professionalism of our Public Safety Department and the men and women that work every day to provide a safe place for all to live, work, and visit.

Frequently Asked Questions**

Statement

The East Grand Rapids Department of Public Safety is responsible for enforcing state law and city ordinances within the City of East Grand Rapids, Michigan. All sworn Public Safety members are cross-trained as firefighters and emergency medical service providers. Public Safety strives to maintain a safe and welcoming community for residents, visitors and community members. The Department maintains a highly motivated, professional staff who make the East Grand Rapids a safe place to live, work and visit.

The East Grand Rapids Department of Public Safety is neither responsible for, nor has the authority to, enforce federal civil immigration laws used to detain or remove undocumented immigrants. The Department has not, does not and will not serve as a civil immigration enforcement agency for the federal government.

East Grand Rapids Public Safety Department's Federal Immigration Policies and Practices Summary

The national debate surrounding immigration enforcement has raised questions of how the City of East Grand Rapids Public Safety Department handles these issues. This is a summary of the East Grand Rapids Public Safety Department's long-established policies and practices regarding Federal Immigration enforcement.

- East Grand Rapids Public Safety Officers do **not** have inherent authority to enforce civil immigration law unless specifically authorized under federal law such as a 287(g) or other agreement. No such agreement is in place and would require City Commission approval to enter into one.
- East Grand Rapids Public Safety Officers have the authority to make arrests, custodial or otherwise, for violations of ***Michigan law and city ordinance violations***. See *MCL 764.9c*.
- The City of East Grand Rapids Public Safety Department has not, does not, and will not work in conjunction with ICE and/or Border Patrol to actively look for violators of civil immigration laws.
- The East Grand Rapids Public Safety Department has not and will not accompany federal immigration agents to residences in East Grand Rapids or elsewhere to conduct civil immigration enforcement.
- The City of East Grand Rapids Public Safety Department does not have a 287(g) agreement or any other memorandum of understanding with federal immigration agencies. A 287(g) agreement gives local law enforcement training, certification and the authority to enforce immigration law.
- The East Grand Rapids Public Safety Department will not investigate civil immigration violations or contact federal immigration authorities, including ICE and/or Border Patrol, during calls for service, traffic stops, or other routine police activity, unless a valid and authorized judicial warrant or court order exists.
- This does not limit our authority or responsibility to arrest individuals for criminal offenses, including violent crimes. Our commitment to public safety, maintaining peace, and enforcing state and local laws remains unchanged.
- Ensuring the safety of our community and providing clear, lawful guidance to our officers are the primary objectives in our community. It is our priority to make the City of East Grand Rapids a safe place to live, work, and visit.
- East Grand Rapids' Public Safety policies and procedures are in line with other Michigan and National Law Enforcement agencies.

Frequently Asked Questions

- 1. Do East Grand Rapids Public Safety officers have authority to engage in immigration enforcement based on their license as a Michigan law enforcement officer?***

No. Under federal law, department personnel are prohibited from investigating or arresting a person for civil immigration purposes. That authority is within the purview of federal law enforcement officers employed by U.S. Immigration and Customs Enforcement (ICE) and U.S. Customs and Border Protection (CBP).

Local law enforcement officers have the authority to make arrests, custodial or otherwise, for violations of state law or for a city ordinance violation. See [MCL 764.9c](#).

- 2. What would grant an East Grand Rapids Public Safety officer the authority to enforce civil immigration laws?***

This would only be possible if the City of East Grand Rapids entered into a 287(g) Memorandum of Agreement (MOA) or other similar agreement granting authority. See 8 U.S.C. § 1357 and INA § 287(a)(4) and 8 C.F.R. § 287.5(c)(2).

Enforcement of civil immigration laws is the responsibility of federal immigration authorities, such as ICE and CBP. Local law enforcement officers do not have inherent authority to enforce civil immigration law unless specifically authorized under federal law such as a 287(g) or other agreement. No such agreement is in place with the City of East Grand Rapids.

- 3. Can East Grand Rapids Public Safety officers arrest someone who has an outstanding arrest warrant for violating a criminal immigration offense?***

Yes. In a lawful investigation, an officer can arrest someone who has an outstanding arrest warrant if the officer learns that a suspect has a criminal arrest warrant signed by a federal judge. The arrest warrant must be confirmed,

and the suspect will be taken into custody in addition to local charges, if applicable.

It is important to note that an arrest warrant is a court order signed by a judge and does not grant the officer or Public Safety any discretion to ignore the court order.

4. Can an officer stop and detain someone to determine their immigration status?

No. Under federal law, a stop requires an officer to have reasonable suspicion of a crime being committed. Stopping someone to inquire about their immigration status would be a violation of that standard as well as several existing policies contained in the [EGR Manual of Policies and Procedures](#). Officers violating these policies would be subject to discipline up to and including termination.

5. Does the Public Safety Department's Manual of Policies and Procedures address civil immigration enforcement?

Yes. The Department's [policy manual](#) has multiple sections applicable to civil immigration matters, including:

Section 3-25

Fair and Impartial Policing

States in part:

C. LAW ENFORCEMENT ACTION OR SERVICES. Personnel:

1. Are prohibited from bias influenced policing in all law enforcement encounters.
2. Shall treat all people in a fair and impartial manner during all law enforcement encounters, when providing any service, and in accordance with the law (e.g., Title VII of the Civil Rights Act 1964, the Michigan Elliott-Larson Civil Rights Act, etc.) or taking any enforcement actions such as public contacts, traffic stops, field interviews or investigations, asset forfeitures, arrests, searches and

seizures, detention of a person, etc. Examples of traits or lifestyles that may cause a bias reaction include:

- Race
- National Origin
- Ethnic Background
- Gender
- Gender identity
- Sexual orientation
- Religion
- Marital Status
- Economic Status
- Individuals with Disability
- Age
- Cultural group

F. EMPLOYEE RESPONSIBILITIES. Employees:

1. Are required to comply with the law, Department policy, procedures, rules, regulations and/or directives.

Section 10-19

Searches, Strip Searches, Body cavity Searches

States in part:

10. *Border searches.* Michigan law enforcement officers do not enforce customs or immigration laws, except in conjunction with Federal agencies. (Unless a signed 287g agreement is in place with the governmental agency).

Section 3-7

The Constitution of the United States of America

States in part:

AMENDMENT 10 - Powers of the States and People

The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people.

The 10th amendment limits federal authority over state and local police regarding immigration enforcement through:

- **Anti-Commandeering Doctrine:** The Supreme Court has ruled that the federal government cannot compel states or localities to enforce federal law, including immigration, as this would violate state sovereignty.
- **Voluntary Cooperation:** Local police are not required to honor federal immigration detainers (requests to hold individuals).
- **Formal Agreements (287(g)):** While the federal government cannot force local, voluntary participation, it can enter into 287(g) agreements, where local officers are trained and deputized to assist with immigration enforcement.

In other words, the 10th Amendment empowers local law enforcement to choose whether to engage in federal immigration through a signed 287g agreement, affirming that they are not agents of the federal government.

Section 10-4

Arrest Management

States in part:

- A. **ARREST AUTHORITY.** In order to have a valid arrest, the elements of authority, intent, force, custody, and submission must be present.
1. **Authority:**
 - a. Refers to the person making the arrest.
 - b. To arrest is vested in employees who are fully empowered and regularly employed by the East Grand Rapids Department of Public Safety.
- D. **ARREST REQUIREMENTS**
1. *Arrest warrant required.* An arrest warrant:

- a. Commands an officer to immediately arrest the named person and make them available for court proceedings. Sworn personnel shall:
 - 1) Positively identify the individual
 - 2) Confirm the warrant through LEIN, Possess the warrant or have knowledge a warrant has been issued.
 - 3) Advise the suspect they are under arrest
 - 4) Place the suspect in handcuffs or under arrest
 - 5) Transport the suspect to the Kent County Jail/designated facility or allow to post bond if able.

***Note:** These steps do not have to occur in specific order

DEFINITIONS

Civil Immigration Violation: breach of United States federal immigration laws or regulations that is not classified as a criminal offense but rather as a civil matter. Civil immigration violations typically involve conduct that renders a noncitizen subject to administrative removal proceedings, rather than criminal prosecution. Civil immigration law is found in the United States Code of Federal Regulations.

Code of Federal Regulations: (CFR): the Code of Federal Regulations (CFR) is the annual codification of general and permanent rules published by U.S. federal agencies in the Federal Register. Divided into 50 titles representing broad subject areas, it constitutes the official, legally binding regulations. These laws are investigated and enforced by authorized federal agencies and officers.

Criminal Immigration Violation: conduct that violates United States federal immigration statutes and is classified as a criminal offense, as opposed to a civil violation. Criminal immigration violations typically involve actions that are prosecuted in federal court and may result in criminal penalties such as fines, imprisonment, or both. Criminal immigration law is found in the United States Code of Federal Regulations.

Customs and Border Protection (CBP): federal agency of the United States government, established within the Department of Homeland Security (DHS) responsible for border security, trade facilitation, and enforcement functions.

Immigration Administrative Warrant: commonly DHS form I-200, Warrant for Arrest of Alien or DHS form I-205 Warrant for Removal or Deportation are administrative civil documents issued between one immigration officer to another immigration officer. These documents are not issued between an immigration officer and a local law enforcement agency and are not arrest warrants issued by a Judge.

Immigration and Customs Enforcement (ICE): principal United States law enforcement agency within the Department of Homeland Security, tasked with enforcing immigration and customs laws, conducting investigations, and managing detention and removal operations.

Michigan Criminal Arrest Warrant: legal document signed by a Judge or Magistrate authorizing law enforcement to arrest an individual for alleged criminal activity or for failing to comply with court orders. These are signed by a Judge or Magistrate and are on a form created by the State Court Administrative Office. It commands a peace officer or court officer authorized to make an arrest to take the subject into custody.

287(g) Agreement: a Memorandum of Agreement (MOA) between the federal government and the local governmental entity, that constitutes an agreement between United States Immigration and Customs Enforcement (ICE), a component of the Department of Homeland Security (DHS) and the local government, pursuant to which ICE delegates to nominated, trained, and certified local law enforcement officers the authority to perform certain immigration enforcement functions.

A. **PURPOSE.** To emphasize the Department's commitment to fair and impartial treatment of all persons when providing public safety services.

B. **DEFINITION**

Bias-based (influenced) policing. The differential treatment of individuals in the context of rendering public safety services based solely on subject classification, traits, beliefs, or lifestyles.

C. **LAW ENFORCEMENT ACTION OR SERVICES.** Personnel:

1. Are prohibited from bias influenced policing in all law enforcement encounters.
2. Shall treat all people in a fair and impartial manner during all law enforcement

encounters, when providing any service, and in accordance with the law (e.g., Title VII of the Civil Rights Act 1964, the Michigan Elliott-Larson Civil Rights Act, etc.) or taking any enforcement actions such as public contacts, traffic stops, field interviews or investigations, asset forfeitures, arrests, searches and seizures, detention of a person, etc. Examples of traits or lifestyles that may cause a bias reaction include:

- Race
 - National Origin
 - Ethnic Background
 - Gender
 - Gender identity
 - Sexual orientation
 - Religion
 - Marital Status
 - Economic Status
 - Individuals with Disability
 - Age
 - Cultural group
2. Must articulate specific facts and inferences drawn from those facts that establish reasonable suspicion or probable cause to justify a stop or enforcement action.
 3. When practical and absent exigent circumstances, should accommodate a subject who through observation or articulation of particular facts has a(n):
 - Physical or mental disabilities
 - Injury
 - Illness
 - Infirmary
 4. Should accommodate a person lacking English proficiency or is deaf or deaf/blind and cannot communicate without an interpreter or other assistance.
- D. USE OF TRAITS FOR REASONABLE SUSPICION OR PROBABLE CAUSE. Officers may use traits and characteristics such as age, race, ethnicity, or national origin along with descriptive features such as hair color, height, weight, or gender to assist in establishing reasonable suspicion or probable cause or for other legitimate law enforcement purposes.
- E. PERSONAL INVOLVEMENT OR CONFLICT OF INTEREST. To prevent inappropriate perceptions of biased law enforcement, personnel:
1. Shall refrain from any investigations that involve a person with whom they have a private or intimate relationship, a relative, or when off duty and involved in the incident.

2. May still act in an emergency involving self-defense, imminent threat of serious or life-threatening injury to a person or when a serious offense is being committed. Personnel should notify the appropriate law enforcement agency/dispatch center, as soon as practical, that the member needs assistance for the emergency.
3. (Reference criteria in E.1.) shall immediately notify an EGRDPS supervisor to investigate the incident if the incident occurred in East Grand Rapids. If the incident occurred in another jurisdiction, EGR personnel shall notify an appropriate law enforcement supervisor from that jurisdiction to investigate the incident. Personnel shall notify the Director of all such incidents according to Department policy and through the appropriate chain of command.

F. EMPLOYEE RESPONSIBILITIES. Employees:

1. Are required to comply with the law, Department policy, procedures, rules, regulations and/or directives.
2. Are obligated, when they have the means and opportunity, to intervene if they observe other employees or those assisting the Department or being assisted by the Department engaging in illegal, unfair, partial, or excessive behavior.
3. Shall report, as soon as practical to a supervisor or command officer, behavior that they believe is illegal, unfair, partial, excessive, or inappropriate, or a violation of, or not within the intent of Department policy, procedures, rules, regulations and/or directives.

G. SUPERVISOR RESPONSIBILITIES. Supervisors:

1. Receiving a report of inappropriate behavior shall, as soon as practical, document the complaint and forward it to the Director or designee. If necessary, supervisors are responsible to take immediate action to mitigate the incident.
2. Are responsible for monitoring employee behavior to identify incidents that are illegal, unfair, partial, excessive, or inappropriate or a violation of, or not within the intent of, Department policy, procedures, rules, regulations and/or directives.

H. AUDIT

1. To provide for early intervention, supervisors, during each month of the calendar year, will audit the activity of each member they supervise by reviewing a random representation of video and related reports or documentation. The goal is to ensure all activity and behavior reflects Department expectations, policy, procedures, rules, regulations and/or directives.

- a. Staff Sergeants or designee shall complete a **“Video Review Form”** or other appropriate documentation (i.e., **“Sergeants Daily Activity Report”** and/or memorandum) to the Police Services Captain describing:

- 1) Date of audit.
- 2) Person’s name being audited.
- 3) Marker or identifier of video or audio reviewed.

And behavior observed in audited material that:

- 1) Exceeds Department’s expectation.
- 2) May be considered illegal, unfair, partial, excessive, or inappropriate or a violation of, or not within the intent of, Department policy, rules, procedures, or directives; or
- 3) Indicates additional training is needed to improve safety practices, procedural issues, or the operation of Department equipment.

- b. A **“Video Review Form”** shall be completed monthly on each officer and submitted to the Police Services Captain along with any other appropriate documentation.

2. The Police Services Captain shall:

- a. Review the **“Video Review Forms”** and **“SDARs”** when submitted.
- b. Document and forward observations of exemplary behavior to appropriate individuals and departments.
- c. Document and forward observations of improper behavior to the appropriate authority for remedial training or follow-up investigation for potential disciplinary action.

I. COMMAND RESPONSIBILITIES. The Director or designee shall:

- 1. Complete a written annual meaningful review of agency practices and corrective action taken as it relates to internal affairs complaints/investigations of bias-based (influence) policing or complaints made in the annual MLEAC report.
- 2. Determine if any Department training or policy modifications are needed.
- 3. Provide the MLEAC report to the City Manager and retain a copy as a management record of the Department.

J. TRAINING. The Department shall:

1. Commit to periodic training ensuring that all employees are aware of the social issues involving diversity and what constitutes impartial policing.
2. At a minimum, ensure agency personnel receive bias based police training, including legal requirements and sanctions, annually.
3. Conduct initial training for newly hired personnel regarding the impropriety of bias influenced policing, including legal requirements and sanctions.

K. COMPLAINTS. The Department:

1. Takes all allegations or complaints of illegal, unfair, partial, excessive, or inappropriate behavior seriously.
2. Will investigate all complaints as outlined in the **MOPP Section 3-13: Complaints of Officer Misconduct and Section 3-40: Rules & Regulations**. If evidence is found to support the complaint, appropriate corrective action will be taken in accordance with **Section 3-22: Disciplinary Process**.

L. COMPLIANCE. Violations of this policy, or portions thereof, may result in disciplinary action.

M. OFFICERS ASSIGNED TO OTHER AGENCIES. Department officers assigned to or assisting other agencies shall be guided by this policy.

Mayor and Commissioners,

The City actually has a policy dealing with the City Commission acting on items not within the authority of the City Commission. Attached are an opinion dated April 29, 1982, from the then serving City Attorney, Robert W. Richardson, and a follow up item from Mr. Richardson dated June 1, 1982. The issue which triggered this opinion was a request from a resident that the City support the adoption of a nuclear weapons freeze. After reviewing the Michigan Constitution, the Home Rules City Act, and the City Charter, Mr. Richardson found no authority for the City to act on the question of nuclear weapons. He also cited the Michigan Supreme Court case of Attorney General v City of Detroit, 225 Mich 631 (1923) which found that a municipality possessed no power to legislate a public policy in matters of State concern.

The final paragraph of the opinion indicates that any action taken beyond the authority of the City Commission would constitute no more than the expression of personal views of those City Commissioners voting on the matter. In addition, such action would be without authority as to establishing a position for the City or for the residents of the City.

Very little of the proposed immigration resolution is within the authority of the City Commission. The policies and procedures already adopted by the Department of Public Safety are within the authority of that department with the Director of Public Safety being legally responsible for their development and implementation. This is not a duty assigned to the City Commission. A 287(g) agreement would require approval of the City Commission to be valid. No such agreement is in place nor has such an agreement been sought. For a vote on any grant funding proposal to be valid, it would need to be taken on a proposal for an actual agreement. The direction to the Kent County Sheriff is clearly beyond the authority of the City Commission since the County is the municipal authority that regulates the Sheriff. As you may know, the Sheriff already indicated that the Sheriff does not take directions or orders from the City of East Grand Rapids.

This would leave only the issue of the City providing land or facilities for the establishment of a federal detention center. Such a transfer of City property would require the consent of the City Commission. As noted above, any action taken by the City without authority would not establish a position for the City or its residents.

Gentlemen:

The minutes of the April 19, 1982 City Commission meeting, at item 442, discuss the question of a state and national nuclear war weapon freeze and ask that the City Attorney review the Commission's authority as to making a decision on this matter.

It is our opinion that the matter is not one as to which the City has power to act. Under Article VII, Section 22 of the Michigan Constitution of 1963, it is provided that "Each *** City *** shall have power to adopt resolutions and ordinances relating to its municipal concerns, property and government, subject to the Constitution and law. ***"

The Home Rule Act, under which the Charter of the City of East Grand Rapids was drafted, specifically sets forth certain powers which may properly be included within the City Charter.

The Charter of the City of East Grand Rapids specifies certain actions to be taken by the City government.

We do not find in any of these sources authority for the City to act on the question of nuclear weapons.

The question as to whether or not a city is limited by the powers granted to it under the Constitution and Home Rule Act is discussed at some length in a 1923 Supreme Court opinion in the case of Attorney General v. City of Detroit, 225 Mich 691. In that case, it appears that the City of Detroit had attempted to establish minimum wage regulations. The court found that this power rested in the state and not in the municipality and, at pages 640-641, made the following statement which applies generally to the authority vested in city governments.

"In the provisions under consideration the city has undertaken to exercise the police power not only over matters of municipal concern but also over matters of State concern; it has undertaken not only to fix a public policy for its activities which are purely local but also for its activities as an arm of the State. The provisions apply alike to local activities and State activities. If we assume, as we have for the purposes of the case, without deciding the question, that the city possesses such of the police power of the State as may be necessary to permit it

City Commission - Relative Items (continued)

to legislate upon matters of municipal concern, it does not follow that it possesses all the police power of the sovereign so as to enable it to legislate generally in fixing a public policy in matters of State concern. This power has not been given it either by the Constitution or the home-rule act"

The question relative to the nuclear war weapons freeze is a question which is properly the concern of the national government under the Constitution and laws of the United States and is not within the authority of any municipality. Accordingly, it would be our opinion that the City Commission is without authority to make a decision on this matter.

Any expression of views or other action by the City Commission on this subject would constitute no more than the expression of the personal views of those City Commissioners voting on the matter. On the basis of the Constitution, statutes and case law as discussed above, such action would be without authority as to establishing a position for the City or for the residents of the City.

TITLE: CITY COMMISSION - AGENDA - RELEVANT ITEMS

John Huff's notes from the May 17, 1982 City Commission meeting included a request that I again comment on the question of the scope of the authority of the City Commission as discussed in my April 29, 1982 opinion.

In response to the inquiries made at the May 17, 1982 meeting, my opinion is as follows:

1. The public and each member thereof has the right to bring before the City Commission any matter which such person believes to be proper.

2. The City Commission may, if it determines that the subject matter is not a matter for municipal concern as discussed in my April 29, 1982 opinion, so inform the petitioner and terminate the discussion. In the alternative, the City Commission may elect to hear the matter fully even though it has no authority to act in regard to the matter.

3. If the matter is not one of municipal concern, the City Commission should take no action by resolution or ordinance relating to the same. This could be done by adoption of a motion to the effect that the matter is not one of municipal concern and that therefore no action is being taken. The same result could be achieved without such a motion, merely by taking no action at all.

NOTE: Please be mindful of engaging in extended discussion that, while well-intentioned, does not clearly convey specific direction to staff. Open conversation is an important part of deliberation, but when dialogue becomes broad or speculative, it can create uncertainty about priorities, expectations, and next steps. Staff may be left interpreting individual comments rather than receiving a clear, collective sense of Commission's will.

To support effective governance and efficient use of staff time, Commission discussions should strive to culminate in concise, actionable direction. Clarifying decisions and articulating desired outcomes helps ensure that conversation translates into progress. Being deliberate about when discussion is exploratory and when it is directive will strengthen communication, accountability, and follow-through.

EXAMPLE: There was rich conversation about Commission's desired direction on the Cross Town Connectors. Differing opinions we expressed, questions we answered, and options we offered. However, we could easily have moved onto the next initiative without verbalizing direction to the staff. This leaves staff having to guess and perhaps allocate resources (or not) in inefficient ways. In the end, the Commission, AS A UNIT chose not to pursue for FY26, rather revisit in 2027, aligning with planned construction projects, and staff will staff provide additional design options. This can minimize downtown and destruction and optimize cost.

Dig Deeper into Complicated, Controversial Issues

Work sessions are vital for city commissions because they provide a focused, less formal setting where complex, complicated, or controversial issues can be explored in depth before being brought to a public meeting. In a work session, commissioners can ask detailed questions, examine data, consider multiple perspectives, and engage in candid discussion without the pressure of making immediate decisions or performing for an audience. This deeper level of analysis leads to more informed, thoughtful outcomes and helps prevent confusion or conflict during formal commission meetings. By reserving public meetings for clearer, well-vetted proposals, city commissions demonstrate respect for the community's time while improving the quality, transparency, and effectiveness of their decision-making.

Create a social contract

Creating a social contract for a city commission can provide a powerful foundation for rebuilding trust, clarity, and effective collaboration. By clearly defining shared values, expectations, and standards of conduct, a social contract helps commission members move beyond personal conflicts and refocus on their collective responsibility to the community. It establishes agreed-upon norms for communication, decision-making, and accountability, reducing misunderstandings and destructive behavior. When embraced in good faith, a social contract can transform dysfunction into structure, encourage mutual respect, and create a stable framework that supports more productive governance and better outcomes for residents.

This, of course, must be "embraced in good faith" with the genuine intention to serve the community as an aligned unit rather than putting personal interests and positions first.

NOTE: WORKING AS A HIGH-FUNCTIONING LEADERSHIP TEAM doesn't happen by accident. Consider taking a few minutes, regularly, at your work sessions to discuss your productivity, as a team. It's not just what you do, it's also how you do it:

- ♦ *How are we currently functioning?*
- ♦ *Are we able to utilize our time together efficiently, effectively, and productively?*
- ♦ *Are we able to discuss, even the tough issues, with respect?*
- ♦ *Do we really hear each other?*
- ♦ *Are each of us acting in ways that model behaviors expected for the City?*
- ♦ *Do our behaviors increase confidence and trust and reduce tension for residents?*
- ♦ *Where can we improve to be even more effective as we move forward?*

NEXT STEPS

- ✓ This report of generated ideas is created and sent to City Manager Charles, who will review and send to Commission members and Senior Staff.
- ✓ Once reviewed and approved, the City Staff will once again align Commission priorities to annual budget and report back to council.

The current Special Event policy allows 2 events (with road closures) each month, there are currently 6 events with road closures outside of Gaslight Village.

Director Melville has suggested they use the same out and back as the Reeds Lake Run and the Gobble Wobble, which starts and ends at the Community Center. Spring is very busy in EGR, with events such as soccer at Manhattan Park and the Middle School. The pools are always busy as well. Coordination between School events and Parks and Recreation to lessen the impact on the community.

Jacoby – Noted that parking and bussing can be even more of a challenge.

2026 Revive 5K Approved

Fred Bunn Trails Maintenance and Improvement Projects: The multi-use trails were added to Manhattan Park in 2023/24 in collaboration with West Michigan Mountain Biking Alliance (WMMBA), where they provide maintenance and expertise to the city. This group has extensive experience and provides a high level of support. During the 2025 water main project, Manhattan Park the upper loop near Manhattan Park was disrupted. While the area was restored well, they are not trail experts. Because of this the trail needs a more detailed level of restoration by the original trail builder. The cost of the restoration will be covered by money set aside for the water main project.

Trailside enhancements, the area west of the sledding hill are on a steep grade, segments of the trail are susceptible to erosion. This area is not used as much as the outer loop, suggested amenities are rock armor for the steep slopes, which are stones covering parts of the trail to reduce washouts. Adding small jumps, basic jumps, not like a skills course and tabletops, rollers are intended to be built into the side of the trail. These can be bypassed by bikers, walkers and hikers. These amenities provide more variety of use for the trails. The contractor could do the restoration and amenities at the same time.

Brown: What is the timeline for this?

Melville: Not sure yet but hoping to get on the schedule late spring or early summer. The timeline is also dependent on the vote of the Commission. The restoration project should only take a few days. The current fix is not sustainable.

Burdick: Many invasive species were removed, which is great, but can more be removed with the trail maintenance?

Melville: There is not a specific plan of attack and will coordinate with Kent County Conservations District.

Brown: Rock armoring can get mossy, personally would like to see gritty stones be used, not smooth. The tabletop features already out there are great. The main trail should be the straight shot, and someone should veer off for any special biking experiences. Voiced concerns about jumps, young people might not use them properly.

Smith: The Interurban Trails have jumps that are on the side. Noted that quite a bit of visibility is needed.

Brown: Feels that jumps don't fit the appetite for the multi-use trails.

Parkes: Asked if adding rock armoring could cause more injury from falls?

Melville: The rock armoring is intended only for the steeper areas. Injury can happen. Algae will make it slippery, clay is the same. Trails should be avoided when they are wet and slippery.

Le: Is this a win-win with WMMBA doing the improvements?

Melville: Rock armoring is a preventive measure, which might be needed in the future. WMMBA is willing to cover the cost of the extras. The restoration from the water main is being paid for by the city.

Brown: Would like to avoid any wooden features because they rot, Suggests the use of stones and natural materials.

Melville: Believes these amenities are dirt but will clarify.

Waterfront Park Phase II Grant Award: Director Melville applied for 3 DNR Grants and East Grand Rapids was awarded the biggest grant of \$500,000. The conceptual design is approximately 15 years old. A Request for Proposal "RFP" is needed for a landscape architect. Similar to the Manhattan Park construction, the architect will help coordinate and hold community engagement and collect feedback.

The former owner of the property clearcut and filled in some wetlands with the intent to build condos. The city purchased the property with a DNR Acquisition Grant and would like to return the property to what it was before.

Some areas of interest include:

- Potential parking lot expansion
- Native tree planning
- Restoring wetlands
- Construct sustainable trails and boardwalks
- Overlook decks
- Possible fishing opportunities
- Possible outdoor learning area
- Educational signage for species and wetland information
- Bike racks and trash cans

There is quite a bit of paperwork required. The DNR should send the project agreement around July. The Department of Environment, Great Lakes and Energy “EGLE” will need to issue a permit because wetlands are protected, before the grant is finalized. Contact has already been made with EGLE. The final design is estimated to be completed later this summer. Timeline to go out for bid is late 2026 or early 2027, which is subject to change. Hopefully 2027 will be the construction year. Parks and Recreation Commission will have approval opportunities as they arise.

Parkes: Which comes first, the architectural firm or the community engagement?

Melville: Community engagement is the first step. Based on what the community wants will determine if the EGLE permits are needed. Preliminary designs from the consultant will be obtained and EGLE will be involved in that process.

Steps:

1. Community engagement
2. Conceptual Designs redone
3. Updated wetland delineations
4. Final designs (Where are trails and wetlands located? How long are boardwalks?)

Bratt: EGLE Like to see restoration of wetlands. Congratulations on receiving this grant!

Burdick: Stated that the Parks and Recreation Commission made a hard decision to allow this grant to happen. Thank you for the hard work done here and thank you to the commission for the hard decisions.

Brown: Thank you! This was an investment to submit the application.

Melville: Our grant scored in the top 10 of all the awards this year.

Brown: Is this grant strictly Waterfront Park or is Remington Park included?

Melville: Property deeds were submitted as part of the application. This property parcel was already designated as parkland and perpetuity. The east part of the park received a grant in the past. Work cannot extend into Hodenpyl.

Brown: Could some of these grants help deal with invasive species at Waterfront Park?

Melville: A map was provided and nothing on the east side was proposed, but we can look into it.

Brown: Previously a playground at Waterfront Park was proposed, is this off the table?

Melville: It's not off the table. The playground was part of the other two grants we applied for. If the community wants a playground for younger children at that park, it could be added at the city's expense. No grant money (or match) can be used for a playground.

Smith: Is excited for the outdoor classroom, it would be the closest wetland learning area to several schools.

Report of Director:

- There is a Middle Schol basketball game this evening and a cashless option is being piloted. Fees for services such as GoFan were high, so we are using Square. This will give another, much needed, option to pay and reduces the need for cash and change.
- Parks and Recreation have been granted permission to use the gym at Woodcliff, which is great for the younger kids.
- The East Basketball Tournament was this past weekend and 3 of the teams from East won! The club was started as part of vertical alignment and has 12 teams, 5 girls and 7 boys.

Burdick: Could middle school students get in for free to games? Kids just want to see their friends play.

Melville: We can look into that.

Smith: A student's season ticket could be a shirt purchased for \$10, they could be students only and be a fun color.

To Commissioners-

The proposed Resolution has no basis in the authority granted the Commission to oversee the governance of the City. Nor does it promote or improve the interests of the City's residents.

The Resolution purports to establish a commitment to protecting "the dignity, welfare and safety" of the City's residents and visitors. However, that commitment is already established. See, EGR Public Safety Dept, Mission, Vision and Values Policy which requires our Public Safety officers and personnel to "treat all people, communities and cultures with compassion, courtesy, dignity and respect". See, also, EGR Public Safety Department, Fair & Impartial Policing Policy, which provides that all Department personnel "treat all people in a fair and impartial manner" and "in accordance with" federal and state civil rights laws.

The Resolution provides that "immigration status" is to be included as a named "protected class" in the Department's Fair & Impartial Policing Policy. However, that Policy does not name any protected classes. Indeed, the term "protected class" is not included anywhere in that Policy.

Despite the Resolution acknowledging that EGR's City government "has no role nor jurisdiction" in the enforcement of federal immigration laws, the Resolution prohibits Public Safety personnel from "participating in federal immigration enforcement activities."

Finally, the Resolution purports to "call on" a law enforcement department (Kent County Sheriff) controlled by a different governing body (Kent County) to change its policy regarding cooperating with federal law enforcement. A call which the Kent County Sheriff's Department has already and unsurprisingly confirmed will not "dictate policy or operations at the Kent County Sheriff's Office."

Thus, this Resolution is - as it was reasonably characterized at the February 6 town hall -- no more than a political statement. A political statement which Commissioner Groff-Blaszak stated at the town hall is meant to "pressure" the Kent County Sheriff to change its policies.

Where in the EGR City Charter or the governing ordinances is the Commission authorized to make political statements about the policies enacted by a different governing body? Political statements made in the Commission's official capacity and thus, ostensibly made on behalf of the residents of the City?

Consistent with the Commission's specific and limited role acting as representatives of the City's residents, I suggest that this Resolution be rejected and that going forward the Commission avoid getting involved in extraneous political issues.

My name is Cindy Burch and for the past 26 years I've lived at 1578 Robinson Rd SE. My husband and I live on the dividing line between Grand Rapids and East Grand Rapids. We regularly bike, shop, recreate and enjoy EGR - a beautiful, peaceful and safe place.

I'm writing to express my gratitude to the commissioners who introduced the safety policy proposals and to urge you to pass Resolution 2026-1. Thanks to what happened in Minneapolis, we don't need to imagine what our cities would look like with a heavy ICE presence; we were shown. Minneapolis, its neighborhoods and schools, will be years recovering from the damage done by ICE. Protesters and residents were not at fault. An ill-trained, well-armed group of men caused that violence. ICE agents behaved abysmally and wreaked chaos and havoc where there previously was none.

Our federal government would have us believe that ICE is keeping us safe from "the disgusting monsters including pedophiles, murderers and fraudsters who live in American neighborhoods" yet actual data tells a different story. "Of those arrested by ICE in Michigan last year, nearly three-quarters did not have criminal convictions." GR Press, Sunday, January 25, 22026 Instead the majority of people being picked up and sent away are long-term residents who have jobs, go to school and have families. They are husbands, fathers, mothers and students. Many have spent years trying to obtain legal permanent status.

Yesterday NPR did a piece where the principal of a school in Minneapolis talked about the affects ICE presence has had on her students and teachers. She said the worst time of the day comes at 3:00 when the children leave school and where ICE agents continue to wait outside the building. Many of the students of color now feel the need to carry their passports to and from school. Or have just stopped attending altogether.
